- 2. The conditions of the sale being met by July 30, 2021 with the sale and transfer being effective November 1, 2021; and,
- That the building is sold "as is, where is" and upon final sale, the purchaser will release both The Medicine Hat Catholic Board of Education and the Minister of Education from any obligation or liability

- regarding the property and after the transfer of ownership the purchaser will indemnify The Medicine Hat Catholic Board of Education and the Minister of Education from any future liabilities to any environmental condition of the property.
- 4. That the deposit from the purchaser, after the conditions have been met by July 31, 2021, be increased to \$75,000.
